Cm. Garza asked how, when there were zone changes or CUP conditions, they would go back, for instance when a residential zone now had a commercial application, to see if it were addressed with the appraisal district to make sure that the property now had the appropriate value.

Planning Director Nathan Bratton stated that on new subdivisions being platted, the appraisal district was kept abreast of them. He added that on zone changes, the appraisal district picked those up themselves when they did appraisals onsite. When a building permit would applied for, the appraisal district would have access to the permit information which was sent every six months.
