Armando Cisneros spoke on nepotism, stating that it was when private life overlapped into public life; he added that nepotism laws were meant to prevent helping someone in your family so that you would focus on what you were supposed to be doing. He concluded that Texas anti-nepotism laws prohibited governmental entities from hiring close relatives of governmental officials.

George Altgelt spoke on the right to freedom of speech, stating that the governing body could not limit what Dr. Farias said.

Richard Geissler spoke on the Ethics Committee and said that the Council should pick the very best that they could for the Commission.

- 64. Consideration to reject the sole bid received for FY12-087, for the furnishing of cleaning services for domestic sewage back-ups into private properties. This service will be done in-house by the Utilities Department.
- 65. Authorizing the City Manager to execute an agreement with STW Soccer Academy from Laredo, Texas, for the lease of property east of the Mary Help of Christians Booster Station on Springfield Avenue in the amount of \$200.00 per year. Facility will be used to operate a soccer academy youth training center sanctioned by the American Soccer League, and includes the construction of facility improvements.

- B. Request by Council Member Alejandro "Alex" Perez
- 1. Discussion with possible action to approve the continued expanding support of 406th Drug Court Program by providing El Metro bus passes for use by the participants.

Victor Oliveros, Jr., representing the 406th State District Court and the Webb County Drug Court Program, said that this was a national program that provided very intensive and rigorous substance abuse treatment and education for individuals that had committed crimes against the state except violent criminal offenders. He added that upon completion of the program, they were eligible for dismissal of their charges.

City Manager Carlos Villarreal said that they probably could not give a discount; there were organizations such as Child Protective Services, SCAN, Casa de Misericordia, etc. that also have to buy tickets. He added that maybe they could work with them on hiring a driver and meet with some of the commissioners as this was more of a county responsibility.

- C. Request by Council Member Jorge A. Vera
- 1. Discussion with possible action on amending the zoning ordinance(s) regulating sexually oriented businesses.

Cm. Vera said that in his district, he had many M-1 zones which would allow for the establishment of many of those types of businesses throughout. He wanted to establish a single area or zone for those types of businesses because he had M-1 zones abutting residential areas.

Planning Director Nathan Bratton replied that there were legal implications involved. He said that one possibility was removing them from M-1 zones and allowing them only in M-2 zones.

City Attorney Raul Casso asked for time to study this issue further with Planning Director Nathan Bratton.

D. Request by Mayor Pro-Tempore Cynthia Liendo Espinoza

1. Presentation by Kristi Peña, Better Business Bureau of San Antonio, regarding all of the services and available resources by the organization for Laredo residents.

Kristi Peña reported that her time here was awareness of the Better Business Bureau for Laredo. She invited Council to participate in quarterly luncheons or a Protect Your Business summit.

2. Discussion with possible action on implementing an anti-vandalism campaign including Text-A-Tip Program. (Co-Sponsored by Council Member Mike Garza)

Mayor Pro Tem Liendo Espinoza stated that they would be debuting an antivandalism campaign on October 2nd as part of the National Night Out festivities. She felt that this would be a great opportunity to also start with the Text-A-Tip program.

Interim Police Chief Gilberto Navarro reported that they had explored the Tipsoft application, which worked through a PC or a smartphone. He added that they had looked at other agencies using those programs, but they were all just beginning to use them so that there was little history.

Mayor Pro Tem Liendo Espinoza said she wanted to have the numbers very visible at the parks in the signage.

Interim Police Chief Gilberto Navarro said that there was another program through 3-1-1 which was scheduled to come online in late October. He added that the difference in programs was that the Tipsoft afforded anonymity; the 3-1-1 program afforded accountability. He concluded that by the next meeting, they could show a side-by-side comparison including information from multiple cities that use these programs.
