2. An Ordinance of the City of Laredo, Texas, to include a voluntary drug testing process for elected officials of the City of Laredo; approving the voluntary drug testing form; providing a severability clause; and providing an effective date.

The Laredo Convention and Visitors Bureau and other CITY entities will also advertise the flight service, as part of their normal marketing responsibilities for the City.

11. **2020-O-126** Authorizing the City Manager to ratify the submission of grant application to the Federal Aviation Administration in the estimated amount of \$10,485,466.00 for the Laredo International Airport and authorizing the City Manager to execute all necessary documents resulting from the award. 
