RESOLUTION 2006-R-013

Section 2: The City Council officially finds and determines that the following votes were cast at said election, as per attached tabulation returns included in this resolution, for the following candidates for City Council Member - District VII by the resident, qualified electors of the City of Laredo, who voted at said special election with the following results:
