

**RESOLUTION 2006-R-063**

**CANVASSING THE RESULTS OF THE MAY 20, 2006 RECOUNT OF THE VOTES CAST ON THE GENERAL ELECTION FOR THE POSITION OF COUNCIL MEMBER DISTRICT I AND COUNCIL MEMBER DISTRICT III HELD ON MAY 13, 2006, PURSUANT TO PETITION FILED BY RAMIRO MARTINEZ IN DISTRICT I AND PETITION FILED BY RICARDO HINOJOSA IN DISTRICT III IN ACCORDANCE WITH THE PROVISIONS AND PROCEDURES OF THE TEXAS ELECTION CODE; AND APPROVING THE RESULTS OF THE RECOUNT.**

WHEREAS, by Resolution 2006-R-058 approved on May 16, 2006, the Council canvassed the returns of the General Election held on May 13, 2006 for the office of Mayor, Municipal Court Judge, and Council Members for District I, II, III and VI; and

WHEREAS, a recount petition was presented for a recount of Council Member District I by Ramiro Martinez and a petition for a recount of Council Member District III by Ricardo Hinojosa; and

WHEREAS, a recount was set for May 20, 2006, and all District I and District III candidates were duly notified of same; and

WHEREAS, the City Council officially finds and determines that, pursuant to the final report of the recount committee for the General Election held on May 13, 2006, for the office of Council Member District I and Council Member District III, the following votes were cast at said election:


