RESOLUTION NO. 2018-R-109

CALLING A SPECIAL ELECTION TO APPROVE A CONVENTION CENTER VENUE PROJECT, A NEW FIVE PERCENT (5%) SHORT-TERM MOTOR VEHICLE RENTAL TAX PURSUANT TO SECTION 334.102 OF THE TEXAS LOCAL GOVERNMENT CODE, AND A NEW AND ADDITIONAL TWO PERCENT (2%) HOTEL OCCUPANCY TAX PURSUANT TO SECTION 334.252 OF THE TEXAS LOCAL GOVERNMENT CODE; PROVIDING FOR THE CONDUCT AND THE GIVING NOTICE OF THE ELECTION; PROVIDING FOR PUBLICATION; AND ENACTING OTHER MATTERS RELATING THERETO.

WHEREAS, pursuant to Chapter 334, Texas Local Government Code, as amended, (the "Act") the City Council of the City of Laredo, Texas (the "City") is authorized to call an election to finance as a venue project a convention center and related infrastructure and to pay for such facility, if duly approved in conjunction with such election, from (1) a short-term motor vehicle rental tax pursuant to Section 334.102 of the Act (the "Car Rental Tax")"; and (2) a hotel occupancy tax pursuant to Section 334.252 of the Act (the "Convention Center HOT Tax"); and

WHEREAS, this City Council now determines to pursue the financing of a convention center and related infrastructure within the City limits and the further financing of the maintenance and operation of the convention center (the "*Project*") and to pay for the Project from (1) the Car Rental Tax levied at the rate of five (5) percent on the gross rental receipts from the rental in the municipality of a motor vehicle; and (2) the Convention Center HOT Tax levied at the rate of two (2) percent of the price paid for a room in a hotel; and

WHEREAS, the City has received a determination from the Texas Comptroller of Public Accounts that the convention center venue project will not have a significant negative fiscal impact on state revenue; and

WHEREAS, this City Council finds and determines it is necessary and advisable to call and hold an election within the City of Laredo, Texas on the propositions hereinafter set forth.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO, TEXAS THAT:

Section 1. Election Ordered; Propositions.

An election shall be held in the City of Laredo, Texas, on November 6, 2018, between the hours of 7:00 a.m. and 7:00 p.m., at which election the following propositions shall be submitted in accordance with law:

CITY OF LAREDO PROPOSITION B

Authorizing the City of Laredo to finance a convention center venue to be located within the corporate limits of the City of Laredo and the related infrastructure and the maintenance and operation thereof and (i) to impose a new motor vehicle rental tax at the rate of five percent (5%), and (ii) to impose a new and additional hotel occupancy tax at the rate of two percent (2%) in the City of Laredo, Texas for the purpose of financing the convention center venue project. If approved, the maximum hotel occupancy tax rate imposed from all sources in the City of Laredo, Texas, would be sixteen percent (16%) of the price paid for a room in a hotel.

Section 2. Precincts and Polling Places.

The election precincts for said election only, and the polling place for each such precinct on election day, are set forth in Exhibit A attached hereto, which is incorporated herein by reference and made a part hereof for all purposes.

Section 3. Early Voting.

The Main Early Voting Polling Place, the Branch Early Voting Polling Places for conducting early voting by personal appearance, the dates and hours for early voting by personal appearance and the address for early voting by mail for said election are hereby designated as set forth in Exhibit A attached hereto.

Section 4. Election Officers.

The election officers designated by the Webb County Election Administrator are hereby appointed and confirmed to hold said election at said polling places. As determined by the Webb County Election Administrator, the Presiding Judges shall appoint not less than two nor more than five qualified election clerks to serve and assist in conducting said election; providing that if the Presiding Judge actually serves as expected, the Alternate Presiding Judge shall be one of such clerks. An early ballot board is hereby created to process early voting results, and the individual designated by the Webb County Election Administrator is hereby appointed the presiding judge of said board. The presiding judge shall appoint at least two other members of the board.

Section 5. Ballots.

The official ballots for said election shall be prepared in accordance with the Texas Election Code as to permit the electors to vote "FOR" or "AGAINST" the aforesaid PROPOSITIONS, with the ballots to contain such provisions, markings and language as required by law, and with such PROPOSITIONS to be expressed substantially as follows:

CITY OF LAREDO PROPOSITION B

FOR)

AUTHORIZING THE CITY OF LAREDO TO FINANCE A CONVENTION CENTER VENUE TO BE LOCATED WITHIN THE CORPORATE LIMITS OF THE CITY OF LAREDO AND THE RELATED **INFRASTRUCTURE AND** MAINTENANCE AND OPERATION THEREOF AND (I) TO IMPOSE A NEW MOTOR VEHICLE RENTAL TAX AT THE RATE OF FIVE PERCENT (5%), AND (II) TO IMPOSE A NEW AND ADDITIONAL HOTEL OCCUPANCY TAX AT THE RATE OF TWO PERCENT (2%) IN THE CITY OF LAREDO, TEXAS FOR THE **PURPOSE** OF **FINANCING** CONVENTION CENTER VENUE PROJECT. IF APPROVED, MAXIMUM HOTEL OCCUPANCY TAX RATE IMPOSED FROM ALL SOURCES IN THE CITY OF LAREDO, TEXAS, WOULD BE SIXTEEN PERCENT (16%) OF THE PRICE PAID FOR A ROOM IN A HOTEL.

Section 6. Conduct of Election.

- (a) All resident qualified electors of said City shall be permitted to vote in said election.
- (b) The election materials enumerated in Secs. 272.001, et seq., V.T.C.A. Election Code, shall be printed and furnished in both English and Spanish for use at the polling place on election day and for early voting.
- (c) In all respects said election shall be conducted in accordance with the Texas Election Code. Pursuant to the federal Help America Vote Act and the Texas Election Code, each polling place shall be provided at least one voting system equipped for individuals with disabilities. Sufficient voting equipment to accommodate the voters shall be provided for early voting and at each of the polling places on election day.

Section 7. Notice of Election.

Notice of said election shall be given by (i) publishing a substantial copy of this Resolution in both English and Spanish one time not earlier than the 30th day or later than the 10th day before election day, in a newspaper published in the City or, if none is published in said City, in a newspaper of general circulation in said City and (ii) posting a substantial copy of this Resolution in both English and Spanish on the bulletin board in the City Hall of said City used for posting notices of meetings of the City Council of said City not later than the 21st day before election day.

Section 8. Effective Date.

In accordance with the provisions of V.T.C.A., Government Code, Section 1201.028, this

Resolution shall be effective immediately upon its adoption by the City Council.

Thank you for providing Laredo City Council Resolution No. 2018-R-081 of June 18, 2018, providing for convention center venue project and designating the method of financing for that Venue Project pursuant to Chapter 334 of the Local Government Code.
