#### **BACKGROUND**

City of Laredo owns the exclusive right to name the Stadium located at 6320 Sinatra Drive, Laredo, Texas 78045. Uni-Trade Forwarding Company, L.C. seeks to purchase naming rights to the Stadium in the amount of \$120,000.00 per year for a total amount of \$240,000.00, payable in periodic installments. The agreement shall be for a term of two years, beginning March 19, 2018 and shall include an option to renew for a three (3) year term. Uni-Trade shall receive certain entitlements including the exclusive right to use, occupy and name, Stadium Suite #7 and its associated tickets; the right to host events, subject to approval by the City; the right to install exterior signage at the Stadium; and include the Stadium name on the City's promotional video.
