Cm. Belmares said that the only thing he would ask staff to do would be to look at how they might be able to visit with the Laredo Development Foundation and departments that have energy grants. He thought they could look at these technologies and see what possibly would fit for them. He also felt it was important to open a line of communication with their Congressman.

Whereas one of the most important goals of organized labor is the assist individuals in the pursuit of educational preparation to become qualified to enter the mainstream of American society as successful citizens and

Whereas traditionally the Hispanic population is hindered by a high incidence of poverty this creating an environment of crime, teenage pregnancies, drug addiction, school dropouts, unemployment and this cycle continues and

Whereas a great number of students cannot master the exit examinations, therefore not being able to graduate and

Whereas those that continue into the community college must participate in remedial courses after remaining in such courses for a number of semesters and eventually many leave the institution in debt and

Whereas those that dropout from high school are not ready as they do not possess the necessary educational/technical skills and

Whereas "closing the gaps by 2015" formulated by the Higher Education Board (see attachment) of having more Hispanics in higher education seem unattainable.

Therefore be it resolved that the central labor of Webb county AFL-CIO is embark on an aggressive initiative to remediate the aforementioned barriers facing a large percentage of the Hispanic population and be further resolved that strategies be designed to combat those barriers so that the population addressed to be able to experience success and be productive, law abiding citizens and

Therefore be it further resolved that the national AFL-CIO provide funding/assistance to better the quality of life of the underprivileged population.

Martin Portillo asked how to help the businesses in Laredo because many were being forced to close. It seemed to him that the Solid Waste Department was raising their prices and the businesses could not afford to pay. He said that his intention was to know how they could help the businesses to grow. He felt that the rents were too high for businesses and also that the City was charging too much for their utilities.
