Presentation by Mr. Hector J. Perez, UISD Technology Department Executive Director, regarding cyber bullying and website abuse.

Hector J. Perez, United Independent School District Technology Department Executive Director, gave a comprehensive report regarding cyber bullying and website abuse. He advised that the school would be placing a presentation for parents to view on the Public Access Channel. and an annual average increase in residential rates not less than 17% in 2009, 8% in 2010, 6% in years 2011 through 2014 and 2% thereafter until 2037; and commercial rates of 14% in 2009, 7% in 2010, 5% in years 2011 through 2013 and 2% thereafter until 2037 to of these tiers to be automatically implemented starting on October 1 of each year up to 2037 specifically at the levels indicated in the rate tables provided within this ordinance; Providing for publication and an effective date.

Carlos Villarreal, City Manager, said that the lower rates would not be increased. He added that Council will need to adjust the higher rates if they continue to adjust the lower rates.

Tomas Rodriguez, Utilities Director, advised that staff put the rate at \$8.50 for the first five years. That number includes 12% of the City's 60,000 accounts within that range. The base fee covers up to 2,000. The current sewer is 4,000 as a minimum and water is 2,000.

Cm. Valdez said that the last motion was to keep the initial 0 to 2,000 frozen for life; however, the Utilities Director said that the amount would be frozen for the first five years. He questioned whether the Director can return with corrected adjustments in the numbers. He stressed that he was concerned for the individuals that live on fixed incomes.

Cm. Garza said that he is interested in freezing the amount for life; however, he suggested a 2 or 3 percent increase on the base rate starting after five years.

Tomas Rodriguez said that the last sewer rate increase was back in 1996. He added that the City of Laredo has a commitment with TCEQ to increase capacity on the south side. The City also needs to increase capacity on the north side. He emphasized that the City needs to create additional sewer sites to meet the demands of the City.

Carlos Villarreal, City Manager, said that the City of Laredo had a shortfall of \$1.4 million dollars and there are \$1M dollars that need to be recovered.

Cm. Belmares agreed with the City Manager and asked City Council to adopt the Ordinance.

- B. Request by Council Member Mike Garza
- 1. Discussion with possible action on creating an ordinance for scrap metal purchasing vendors to document where they are receiving their merchandise.

Cm. Garza said that he had consulted with the City Attorney in reference with statutory guidelines for creating an ordinance for scrap metal purchasing vendors to document where they are receiving their merchandise.

Raul Casso, City Attorney, advised that there are statutes in the penal code that address these issues.

Cm. Garza instructed the City Manager to see if the City of Laredo can initiate an investigative tool that will monitor copper and other related items. He said that the City and schools have had desecration of memorials and other items because of this issue.

- 2. Discussion with possible action on securing funding for any related studies and costs for the proposed bridge site #3 be secured from the Mexican government, in addition to reimbursement of costs associated with submittal of presidential permit application for city site #2. (Co-sponsored by Cm. Jose A. Valdez, Jr.)
 - Cm. Garza said that he wanted to bring to light the fact that there was a caveat to the recommendation that came from the City-County Committee which stated that City Council should secure an agreement before a site was selected. He asked Council to agree upon a site before they commit because City Council is struggling to balance their budget and they do not have additional monies to be spending on additional studies and construction cost.

Carlos Villarreal, City Manager, said that the City of Laredo, just like anybody else that constructs a bridge, is in a very unique position because it gives you the authority to be able to sign off on a final agreement that eventually is signed by the Secretary of State or

the Secretary of Communications and Transportation. The agreement is signed between a federal agency in Mexico and the municipality of Laredo. There are many aspects as to how that can be included and made into a valid agreement. The City Council will approve each element that goes into an agreement for the bridge. Staff is hoping to create a memorandum of understanding that will be made part of the final agreement between Mexico and the United States which would have validity.

Cm. Garza asked if you had to get the final agreement to start the process of the presidential permit.

The City Manager, Carlos Villarreal, suggested the initiation of a memorandum of understanding which will outline the reimbursement process

Cm. Garza suggested a 180-day time period for the memorandum of understanding process.

Carlos Villarreal, City Manager, said that it would take approximately three months to create a memorandum of understanding between the City and Mexico. He said that one of the questions that he would be asking is, "Who is going to be signing off for determining reimbursements on the Mexican side?" He questioned if the agreement was going to be signed by the federal government, State of Tamaulipas and the City or between Nuevo Laredo and the federal government? He said that all questions need to be answered prior to signing off on any agreement.

Cm. Garza stressed the importance of having a memorandum of understanding in place before any activities are conducted. He said that the City of Laredo has spent close to three million dollars to get the process of a permit and it cannot be thrown away. It was an investment that the City has completed.

City Manager, Carlos Villarreal, said that the MOU would have to take place before they could proceed to step two.

Cm. Garza emphasized to have a time-certain agreement.

Cm. Landeck said that he has been in attendance at all of the bi-national meetings and the Interlocal Committees and he hopes that someone is keeping track of all the motions and decisions. He said that there was not a caveat but a decision to go to the third site. He went on to say that the Webb County Commissioner's Court did not initiate a caveat. He noted that Judge Danny Valdez told the Mayor of Nuevo Laredo that they would have to discuss some of the issues. He said that he did not know what issues were currently being discussed because no numbers were being distributed. He asked if they were talking about the numbers incurred which include the legal fees and development costs. He emphasized that he did not want to do Mexico a favor by selecting site three.

Motion to instruct the City Manager to initiate a time sensitive Memorandum of Understanding for 120 days.

Cm. Rendon emphasized that he wants the City of Laredo to be reimbursed for studies and permits that were made while the City was seeking to build a bridge. He said that he is not seeking legal funds in the amount that needs to be reimbursed.

Cm. Landeck reiterated that no one mentioned a caveat at the City – County Government Issues meeting. He added that all discussion concerning the bridges need to be in proportion and the viewing public needs to be aware of what each entity is willing to do.

Carlos Villarreal, City Manager, said that he doesn't want people to think that it is going to cost \$200,000 to secure a presidential permit. He said the cost will be over one and a half million dollars. He noted that he has met with the Mayor of Nuevo Laredo regarding charges that will apply for reimbursement. He said that some charges do not apply for reimbursement.

Cm. Garcia mentioned that investments are always risky referring to the bridge investment. He encouraged staff to present the question to the Mexico side and if they are not willing to reimburse that the City should continue to move forward so they can begin recouping the funds that were spent.

Cm. Espinoza said that she was confused as to what the City is asking Nuevo Laredo to reimburse. She said that it would not be fair for the City to ask them to pay for all of the costs incurred on the first original site and ask them to pay again for the costs of site three.

Carlos Villarreal, City Manager, said that Nuevo Laredo would pay for funds that apply to securing the presidential permit.

Mayor Salinas said that the City of Laredo should act in good faith.

Carlos Villarreal, City Manager, said that the City of Laredo needs to be fair.

Mayor Salinas said that the City of Laredo has a responsibility to the tax payers.

Cm. Garza reiterated that the reimbursement costs are associated with the presidential permit process. He suggested having Mexico to pay for all of the studies for the new site. He noted that no legal fees would be associated with that. The City of Laredo has a detailed list of what all the costs are. He asked to amend the motion to run parallel with Webb County.

Motion to instruct the City Manager to initiate a Memorandum of Understanding before any expenditure and make it time-certain for at least a hundred and twenty days. The MOU should run parallel with discussion with Webb County.

City Manager, Carlos Villarreal, said that staff polled City Council on this issue and the consensus indicated that they would not would not prefer a meet and greet with the potential candidates. He said that he would adhere to Councils' decisions.

Cm. Garcia said that City Council should allow the Council Member to make his motion.

Motion to instruct the City Manager to postpone his recommendation until he can arrange a meet and greet for the candidates.

- D. Request by Council Member Juan Narvaez
- 1. Presentation by Mr. Andres "Andy" Ramos regarding property valuations.

Andy Ramos stated that the City has taken the lead for placing important items on agendas. He mentioned that he has sent letters to the City Council and Mayor and other entities regarding the property valuations; however, other entities have not replied. He also thanked Cm. Garza for an article that was published in the Mexican newspapers. Finally, he thanked the Mayor for taking the lead in assisting the disabled and people that are sixty-five and older. He requested for City Council to introduce a resolution to the governor of the State of Texas and legislature to restructure the present method of appraising to arrive at equitable property valuations. Right now, commercial entities have no cap and residential have a 10% cap. He expressed his concerns for the escalating property values. He noted that the Appraisal District, by law, is mandated to appropriate full market value so their hands are tied and the relief that is offered from the District is little at best because of the law. There are 58,168 people that fall below the poverty level in Laredo. The average weekly wage in the second quarter of 2006 was \$530.48 but after the deduction it is \$424.00 a week. In Webb County there is a total of 71% or 43.785 that drive their car to work as of November 2006. He noted that the citizens are faced with higher electricity, gas, groceries, and other items. While salaried employees, in the business sector, remain with the same pay check, businesses in Laredo are hurting and they are starting to lay people off. He added that constituents are suffering. He proposed that City Council introduce a resolution to the Webb County

Appraisal District to appraise properties every three years instead of every year or divide the County into three sections and appraise each section every three years. In addition, he asked every taxpayer that was present or listening to sign a petition on the November ballot as to whether they should be done every three years instead of yearly. Finally, he recommended for City Council to lower their tax rate to provide relief to the constituents.
