**V. STAFF REPORT**

1. Submission of the proposed Fiscal Year 2006-2007 Annual Budget as per Article VI,

Section 6.02, Submission of Budget of the Charter of the City of Laredo which states that "sixty (60) days before the end of the fiscal year, or any time that, the City manger shall present to the Council, in a open public meeting, after proper public notice, and having been placed on the Council meeting agenda, a budget for the ensuing fiscal year with an accompanying message."

Martin Aleman, Budget Director, advised the City Council that the budget process is a lengthy process which begins each year in January. He noted that it gives him great pleasure to present the balanced budget to the City Council. He said that the budget for 2006-2007 is \$392,174,549. He made note that the ending fund balance is \$87,504,397 which is an increase of 6%. He added that this budget includes a total amount of 3.6 million dollars of capital purchases throughout the funds. He submitted a copy of the budget to each Council Member for their review.
