V. COMMUNICATIONS AND RECOGNITIONS

Announcements

a. Presentation to the Council of a framed copy of an 1890 map of the City of Laredo.

Janice Weber, Library Director, and Joe Moreno from Library Archives presented the framed map to the Mayor and City Council. A copy was also presented to the Webb County Heritage Foundation.

The following information was submitted:

"Filed as part of report of Committee of Surveys Feby 6th 1890.
All unmarked streets to be 20 varas in width except those running North and South West of Montgomery Street which are 21 1/2 varas."

The map have the number "00393277" stamped about two inches to the right of the year 1890. Major landmarks on the map included a city park at the present location of Martin High School, U. S. Fort McIntosh, the Yguana Smelting and Refining Company and the H. Garcia grant, Juan E. Farias (grant?), A. G. Markely (grant?), the Mexican National machine shops operations. Also there was a foundry between McClelland St., Loring St. Market St. and the Texas-Mexican railroad lines.

Three railroad lines and depots are noted. These are the International & Great Northern, the Rio Grande and Eagle Pass, and the Mexican National. The I. & G. N. depot was near Fort McIntosh between Matamoros St. and Farragut St. the R. G. & E. P. depot was on the northwest corner of Coke St. and Vidaurri St., and the Mexican National depot was on Montezuma St. between Convent and Salinas St.

Street names are barely visible.

b. Presentation by Cm Louis H. Bruni, Director of the South Texas Rain Enhancement Association, on an up-to-date progress report.

Dear Councilman Bruni,

As of the first week in April, 2000 the project is fully functional with the exception of one aircraft. San Angelo weather mod is currently installing the cloud seeding modifications and telemetry (tracking sys) on this 2nd aircraft.

To give one a perspective of where the project really is and where it has come from along with the dedication and commitment of the board and personnel, I have listed the events and purchases over time.

December

- 1. Commitment by the Association to begin efforts to become self-sufficient.
- 2. Acquired 54 foot tower from Victoria Airport (Ex Nat. Wx. Bureau) free of charge, provided there is no cost to the airport.

January

- 1. Disassemble tower and move to Cotulla via contractor/bid.
- 2. Received permission from LaSalle Commissioners court to erect tower.
- 3. Submitted and received FAA approval to erect tower on the airport.
- 4. Purchased 1st aircraft from Kansas WX Mod completely outfitted with exception of telemetry (tracking) system which is now installed.
- 5. Ordered complete set of cloud seeding modifications for second aircraft.
- 6. Received soil core/engineering specs for tower foundation.
- 7. Received cement engineering specs for tower foundation.
- 8. Purchased a completely remanufactured 74-C weather radar with 8' dish and 12' radome (Best available radar shy of new, 1/2 mil dollars, and one of 2-3 left.)

February

- 1. Drilled 36' pillar cores, set steel, set forms, poured, placed/leveled anchor bolts.
- 2. Submitted and received FCC tower registration #.
- 3. Submitted for licenses from FCC on Radar, Voice, and Telemetry frequencies.
- 4. Hired meteorologist out of the Kansas program, with 2yr/hail experience.
- 5. Began new licensing process, (publishing in 11 newspapers) to add Zapata County and hail suppression to all counties.
- 6. Purchased complete insurance coverage on property and liability for the association.

March

- 1. Purchased 2nd aircraft.
- 2. Erected tower, radar dish, and radome, total height being 66'.
- 3. Purchased 12 X 40 portable building to house radar and office. Tower foundation, erection, building move/set/level/tie in, was accomplished in house.
- 4. Purchased state of the art computer bank to operate the radar, telemetry, internet/Nat Wx Serv monitoring, as well as provider to upload seeding events via www.vsta.com/-synoptic web page.

April

- 1. Submitted the completed process to TNRCC for new license for Zapata County and Hail Suppression.
- 2. Installed latest version of TITAN software via the author Farren Hiscutt form South Africa and Karl Dewaal.
- 3. Installed the telemetry system in the aircraft and radar, to track aircraft on the radar screen which also be uploaded to the internet along with the rain cloud cells.
- 4. Hired full time pilot for Laredo.

- 5. Secured hangar/office space at LaBaTa for the second aircraft.
- 6. Put on line SWTREA's webb page, www.vsta.com/synoptic

John Vidaurri, Parks & Recreation Director, reported on the status of the veteran's flags to be distributed on May 29, 2000.

- B. Request by Council Member Eliseo Valdez, Jr.
 - 1. Request for staff to survey areas available for Little League field practice in District V.

Larry Dovalina, Acting City Manager, stated that he would submit a report to Councilmember Valdez listing city owned properties that might be easily converted into a Little League field for Laredo's youth.

He also stated that staff would have to survey the properties in question to ensure that they are not in a flood zone.

Cm. Galo suggested the use of the two city blocks adjacent to the north of the Seven Flags Park.

2. Request for staff to review and make recommendations on an erosion problem at the 3200 Block of San Francisco.

Rogelio Rivera, City Engineer, reported that his staff has been

working on the erosion problem. He requested that he be allowed to further investigate the project and will submit recommendations at a later date.

C. Request by Council Member Joe A. Guerra

1. Discussion and possible action to use local vendors as much as possible when purchasing merchandise in general and services.

Cm. Guerra complimented Mr. Meza and staff for their fairness in awarding bids. However, he requested staff to be more conscientious to local vendors.

D. Request by Council Member Mario G. Alvarado

 Status report on Mines Road Task Force activities and/or recommendations for traffic control on FM1472, with possible action.

Cm. Alvarado commended Roberto Murillo for his outstanding stewardship. He requested a report of TxDot on the progress of Mines Road. Finally, he expressed his concerns about the status of the Killam Industrial Blvd Project.

He read the following letter:

To: Larry Dovalina, Acting City Manager From: Roberto Murillo, P. E. Traffic Director

The Traffic Department has been diligently working in the Mines Road area fine tuning timing for all traffic signals since Monday, April 17, 2000. By Tuesday afternoon, the six different timing plans designed to provide improved signal progression between Flecha Lane and Killam Industrial Blvd. had been fine tuned and made fully operational. Traffic signal operation continues to be monitored on a daily basis especially during the heavy a.m. and p.m. peak traffic periods and adjustments continue to be made accordingly. Traffic delays have been significantly minimized in the area as a result of these signal-timing improvements and the assistance of the police department in directing traffic when necessary. Different traffic signal plans providing different timing cycle lengths with signal progressions were developed for Mines Road. These cycle lengths are activated throughout the week with the internal clock within each of the traffic signal controllers depending on the time of day. A different plan is activated for each different peak traffic period so as to make any changes to any plan independent on the others. It is important to note that the sequence and timing at the new intersection of Loop 20 and Mines Road was designed and made operational by the Traffic Department specifically for that intersection. The intended sequence in the original design would have significantly minimized available green time for the Mines Road through movements and would have created additional traffic delays. Observations were made between 7 a.m. and 9 p.m. during the week and necessary timing adjustments were made accordingly. During the afternoon peak traffic periods, mainly between 5:00

and 9:00 p.m., traffic backs up continue to be observed in the southbound direction as a result of the heavy amount of truck and vehicular traffic. However, the traffic delays have been significantly minimized with the timing improvements and the assistance of the police department. The opening of the additional traffic lane and the bridge flyover off Mines Rd toward IH 35 by TxDot should improve roadway capacity and in turn minimize the traffic delays through this area. TxDot is constantly being reminded to aggressively pursue completion of these improvements in order to alleviate congestion in this area. We will continue to monitor this area especially during peak traffic periods and implement any additional timing improvements so as to minimize traffic delays to the Mines Road area. Introduction

The purpose of the VIA Program is to promote participation by citizens in the expansion, enhancement and delivery of quality services by the City of Laredo. The goals of the program are to:

- * Encourage and provide opportunities for citizen participation in the operations of city government.
- * Improve the quality of life in Laredo by providing expanded City services without increasing taxes.
- * Enhance the provision of City services by utilizing volunteers to supplement the work of paid City staff.
- * Promote and assist citizen understanding of the programs, issues and problems that municipal governments tackle daily
- * Promote volunteerism within the community

The VIA Program is part of the Nonprofit Management & Volunteer Center, a division of the Laredo Public Library, and is staffed by two people, the Nonprofit Management and Volunteer Center Coordinator and a Clerk IV. The Center is housed in the Main Branch of the Laredo Public Library, at 1120 East Calton Road, Laredo, Texas.

Performance Report

The City of Laredo Volunteers in Action (VIA) Program saw its busiest year ever in 1999. During the past year, the Laredo VIA Program placed a total of 914 volunteers who performed 40,944 hours of service for the citizens of the city. The value of the work of these volunteers totaled \$231,352 for the year. This figure represents an hourly wage savings that would have been paid to City employees for performing the work carried out by volunteers. (The amount does not include benefits and other fringe payments.)

With more volunteers donating even greater amounts of time, VIA has been able to continue providing numerous City departments with volunteer help, while at the same time offering volunteer placements to nonprofit agencies within the City of Laredo. In 1999, VIA placed volunteers with the Laredo Children's Museum, Laredo Animal Protective Society, Laredo/Webb County Food Bank, Laredo Regional Food Bank, Laredo regional Food Bank, Bethany House, Sacred Heart Children's Home, Laredo Community College Lamar Bruni Vergara Environmental Science Center, Ruthe B. Cowl Rehabilitation Center, and the Boy's and Girl's Club.

Of the total number of volunteers, 202 individuals were classified as regular volunteers, or people who freely offered their services, talent and time to the City of Laredo. Of these 202 volunteers, 93 were persons under 18 years of age.

Seventy-eight percent of the VIA volunteers in 1999, or 712 individuals, were community service workers, individuals who were ordered by the court to make restitution for a criminal or misdemeanor offense. Performing community service is an alternative to incarceration or a fine, while still holding offenders accountable.

Work locations within City government represented almost all departments, ranging from the City Manager's Office to the Public Works Department. In all, 34 sites served as locations for volunteers to work during 1999. Volunteers' duties varied from department to department, and included activities such as supervising children at play, shelving books, cleaning up city parks, and helping prepare materials for meetings of the City Council.

An integral component of the VIA Program is having supervisors who are willing to accept volunteers and monitor both their work and their hours. During 1999, City employees at approximately 34 locations served as supervisors to VIA volunteers. Some locations, such as the recreation centers and the Library, attracted the greatest number of volunteers due t the nature of their services. These departments are able to greatly augment service to the public by taking advantage of the strong spirit of volunteer service found in Laredo.

The tables attached to this report detail the activity of the Volunteers in Action Program from February 1, 1999 through January 31, 2000.

Future Plans

For the coming program year, 2000, the Nonprofit Management and Volunteer Center plans to enter into more formal partnerships with both City departments and local nonprofits. These partnerships will allow the development of specialized volunteer programs. One example is the Spring Break Volunteer Program. In partnership with the Communities in Schools, the Center recruits high school students to perform volunteer work during spring break. This type of program helps both the City, which gets volunteer labor when it mist needs it, and the high school student, who are kept off the streets and in a positive environment. This summer, the Center plans to continue its partnership with Communities in Schools by initiating the City of Laredo Summer Internship Program. High school students who have an interest in a specific field, such as computer sciences, accounting, or law, will be placed by the Center with appropriate City department. The high school student gain valuable insight into a professional field, while the City gets much needed volunteer assistance.

Another exciting partnership is with the Laredo Job Corps. The Laredo Job Corps trains young people that have left school, but are still seeking valuable employment skills. In return for the education that the Laredo Job Corps provides, its members are asked to give back to their community by performing volunteer work. With over 200 members, a partnership between the VIA Program and the

Laredo Job Corps could be extremely beneficial for both organizations.

Finally, as part of the training workshops that is put on by the Center, management of volunteers is one of the topics that will be covered in the upcoming program year. This type of training will help to provide a richer experience for both the volunteers and the City departments that benefit from the volunteers' contribution of time and talent.
