12. Status of the groundwater development study by CH2MHill Engineers. Presentation was made to the City Council Water Committee.

Note: Cm. Alvarado joined the meeting at this time, 5:43 p.m., and Cw. Moreno joined the meeting at 5:56 p.m.

Cm. Bruni stated that the Water Committee was concerned with the recommendation from CH2MHill which indicates that our secondary source of water will not be developed until the next four to five years. He added that the Water Committee feels that this secondary source should be implemented within the next 24 months.

Mike Anglea, from CH2MHill, presented to council an overview of the current status on the groundwater feasibility study. Such presentation was previously made to the Water Issues Committee.

GROUNDWATER ALTERNATIVES EVALUATION Status Report for the City of Laredo

OVERVIEW OF EVALUATION

- -Determine whether sufficient groundwater supplies exist to meet or supplement future water demands.
- -Present an implementation plan for alternatives that appear potentially feasible.

APPROACH

- -Identified primary aquifers in the region.
- -Established approximate study area boundary.
- -Developed alternatives for each aquifer within the study area.
- -Evaluated alternatives.

PRIMARY AQUIFERS IN THE REGION

-Edwards Aquifer (1000 to 1500 gallons per minute capacity and

- potable quality in western and central Texas).
- -Carrizo (500 to 1500 gallons per minute capacity and potable quality in northwest and northern Webb County).
- -Laredo (10 to 250 gallons per minute capacity and it is considered non-potable.

STUDY AREA BOUNDARY

- -South Dimmit County
- -La Salle County
- -Webb (northwest, central, northeast, and southeast)

GROUNDWATER ALTERNATIVES

- -Thirteen alternatives were identified in nine geographic areas, using four different aquifers:

- Carrizo
- Laredo
- Catahoula formations
- -The alternatives were evaluated according to 3 factors:
 - Effectiveness (Sustainability)
 - Implementability (Administration and Regulations).
 - Cost (Wellfield, Treatment, Conveyance, O&M).

PRELIMINARY RESULTS: TOP FOUR ALTERNATIVES

- -Carrizo in northwest Webb (bed and banks/pipeline).
- -Edwards Aquifer in Kinney County (bed and banks).
- -Carrizo/Laredo in Laredo Area
- -Carrizo in Dimmit County

GENERAL CHARACTERISTICS OF BEST ALTERNATIVES

-Cost:

- \$1.50 to \$3.50 per thousand gallons versus current cost of \$1.26 per thousand gallons.
- Pipeline represents highest cost.
- Bed and banks represent lowest cost.

-Effectiveness:

- Long-term sustainability is uncertain.
- Competition is moderate to high.
- Expansion potential is finite.

-Implementability:

- Land may be available for purchase or lease.
- Management is critical to ensure sustainable supplies.

ALL OTHER ALTERNATIVES

-Cost from \$3.50 to \$8.00 per thousand gallons.

- -All other factors not as attractive as top five.
- -Other alternatives use same aquifer, just further distance and have poorer water quality.
- -Most expensive alternative is piping water from Kinney County.

RECOMMENDATIONS

- -Consider additional evaluation of top three alternatives:
- Carrizo in northwest Webb County: bed and banks/pipeline.
- Edwards Aguifer in Kinney County: bed and banks.
- Carrizo/Laredo in Laredo area.
- -Evaluate best alternatives as part of an implementation plan:
- Phased approach to detailed evaluation of groundwater alternatives.
- Limits capital costs until uncertainty is minimized.

TYPICAL IMPLEMENTATION PLAN TIME LINE

- -Secure Development Rights:
- Starting now until the third quarter of 1999.

- From the second quarter of 2000 through late 2000.

- From late 2000 through beginning of 2001.

- From early 2001 through third quarter of 2002.
- -Evaluate Operation:
- From third quarter of 2002 through third quarter of 2003.
- -Expansion:
- From third quarter of 2003 through third quarter of 2005.

SUMMARY

- -Groundwater alternatives exist to supplement existing supply.
- -Uncertainty exists about sustainability and protection of groundwater supplies.
- -Top three alternatives need additional evaluation.
- -Assume 4-6 years for full implementation.

(End of report from CH2MHill)

In reference to the portion of the Carrizo Aquifer at southern Dimmit County, Mr. Engly said that they did not go further because of the high demand of that aquifer by Carrizo Springs. So, it is not worth to put an increasing demand on that portion of the aquifer.

On the other hand, the Edwards Aquifer (Kinney County) is such

a long distance away that the only viable alternative considered for it was to use the Rio Grande as a conveyance. That is, put the water into the river and then remove it, so this process will always depend on the Rio Grande. But, of the amount water put into the Rio Grande, roughly 95% will be removed.

Cm. Bruni pointed out that the committee is not in agreement with using the Rio Grande as a conveyance. Pumping the water straight into the Rio Grande will defeat their purpose because the clean water will get mixed with some of the nastiest water in North America. Besides that, if there was to be a spill up river, the water would get contaminated and untreatable.

Cm. Bruni stated for the record, "The bed and banks were not taken into consideration because of their contamination."

Then, Cm. Bruni pointed out to council that there are three companies willing to deliver a secondary source of water to the City of Laredo within 12 months. Each company will provide the information and testing needed; will develop the wellfield, will provide treatment plants and management of the water facility; and deliver whatever amount of water per day to the Utilities Department. In turn, the City will make some kind of commitment to purchase a certain amount of water everyday from them.

Cm. Bruni thinks this is the direction we should go for the economic benefit and development of the City of Laredo. He wants to know what we legally need to do if we need to request for proposals and to expedite the project. He also wants to hold meetings with Enron, as well as meetings with other groups in order to get idea of how much it would cost us to have the water delivered to us.

Cm. Galo stated for the record, that the City of Laredo is spending \$1 million to acquire water rights just to keep up with the projected growth.

Mayor Flores stated that this council is in agreement with an RFP.

Fernando Roman, Utilities Director, stated that it is good news that we have at least one study throughout our consultants, and it was discovered that there is water in the proximity. The challenge to us is to act with a certainty that we are going to have a sustainable supply because once we put our population in that, we are going to make sure that the water is going to be there forever.

In terms of the time schedule, perhaps the only thing he wants to bring to council's attention, is that this is in the absence of not seeing any information from private companies. If they already have that information from the field that it can be analyzed and it might still change. He said that the shorter the field testing period is, the higher the risk that we incur. Mr. Roman added that they are looking at about 12 months worth of studies, which throws off the two year schedule that Cm. Bruni mentioned. He stressed that if we take less that 12 months, the reliability of information is different. In engineering they always look at risks versus time. Because he does not know what information the private companies have, it is hard for him to make a determination.

He added that they have corresponded with some firms, and have stated that we will welcome their studies and proposals as well as the we will follow a certain protocol.

Mayor Flores said that although time is of essence, that she does not think we want to lower the testing period if that is not what is recommended.

Cm. Bruni made a motion to go out for proposals, that it be on a delivery point of treated water to the City of Laredo.

Mr. Roman asked that they establish a standard set of conditions such as quality, quantity, and delivery otherwise the alternatives are not equal.

Mayor Flores suggested that the Utilities Director keep in touch with the committee, if not with the City Council, if there is something that perhaps was misinterpreted on the variables.

Motion to follow the recommendations as presented by the Utilities Director. That staff request proposals (RFP's) from the 4 interested groups regarding the delivery of treated water to a certain point in the City of Laredo and that staff bring a contract so that our Legal staff can review it.

- The City paid \$522,345 in claims for 97 retirees and their dependents in 7 months. If this trend continues, the City could pay out approximately an additional \$373,104 by the end of FY 98-99, for a total of \$895,448.64 (*).
- Ninety-six (96) firefighters were hired prior to July 1, 1988 and therefore, may not be eligible for Medicare. Out of the 96 firefighters, 89 have dependent coverage.
- For a long tenured employee who does not retire and passes

away, the dependents get 36 months of medical coverage unless Medicare eligible.

- Stop loss carrier will be contacted and made aware that surviving spouses and dependents of deceased retirees will have benefits extended beyond the current practice of 36 months;
- If this proposal is passed, previous claims will be considered upon payment of prior contributions;
- There are approximate six (6) dependents who could come forward and state that they should be allowed to participate in our medical plan until Medicare eligible, if applicable. (The six dependents are five firefighter's dependents and one dependent of a regular employee.)
- Current practice has been to allow eligible dependents of deceased employees and retirees to stay in the City's medical plan for no more than 36 months based on guidelines used for C.O.B.R.A. (Continuation of Coverage);
- The City's experience has shown that once benefits are granted to retirees, we have not reduced or diminished those benefits.
- (*) Annualized claims cost for FY 98-99 based on current 7 month trend.

Mr. Migura stated that by looking at the data, there is a trend for increased expenses. The cost is increasing because of medical inflation, cost for doctors/hospitals is increasing, utilization of our benefits plan by more employees, workforce is maturing, and improvement in technology.

He said that before he recommends council to make any significant changes to our plan, he prefers to go out and do a very in-depth rate analysis, bring it back for review, and then make the appropriate adjustments.

He talked with representatives from the collective bargaining association, and told them that he cannot stand before council and make a recommendation because he would be accountable and responsible for this fund.

Cw. Moreno pointed out that Mr. Migura brought information about what it is costing the retirees, but not what it is costing the dependents which was the concern talked about in the previous meeting. She added that Mr. Migura is telling us in his presentation that we cannot afford it, but there is no

information about the particular group we are trying to help. Also, these people will be paying for their medical coverage; we are not giving it to them. All they are asking is for an opportunity "to continue paying for their benefits like the plan says". The plan recurrently says that they are entitled to it. She quoted, "people who have worked for over 20 years and sometimes more than 20, and we don't even want them to pay for the medical insurance?"

Mr. Migura said he brought the information and added that this is a retiree problem not a dependent problem. In reality, it is a fund problem or a medical cost problem. The way they can approach this is that they could include the surviving spouse. There are six (6) dependents identified that could be eligible for this plan if council takes action. What can be done is to include those as well as open it up to all employees, per say for a window of time (through December 31st), which would give Mr. Migura more time to do the rate study.

Cw. Moreno said that we are talking about spouses that probably don't qualify for any other medical coverage, in some cases perhaps because the husband was the only one working. She added that she just can't see that we have a plan that totally excludes those spouses. We are talking about years in service, we are talking about helping those who have been with the plan all those years.

Mr. Migura said that we may have a solution to this problem and accomplish what needs to be accomplished for those individuals that have been identified. A study needs to be done before changing the language where it is all inclusive.

Cw. Moreno said that if the language is not changed, we continue to include everyone, because the language currently includes them. The language says that these people should be covered and we are doing something different. We only need to follow what we are supposed to be doing.

Mr. Migura recommended that it be clarified, so that it will be very clearly specified. He added that the financial liability is undetermined. So, he will do an analysis and make another presentation on November 1999.

c. Cm. Galo commented on Resolution No. 99-4-08 whereby the City will acquire 20 parcels of land for the improvement of the Chacon Creek. He added that residents from this area will be very happy to finally see those parcels cleaned. d. Cm. Guerra presented a letter from Tom Wade (President of the Laredo Transportation Association), regarding Chapter 33 of our Hazardous Materials Ordinance.

Letter quotes:

"I am writing in concern about enforcement of the City of Laredo hazardous materials ordinance. The ordinance, Chapter 33, has some serious problems that are making compliance and enforcement of this ordinance very difficult.

Let me give you some general examples of the compliance problems with this ordinance:

- The ordinance requires a permit to store or handle any material that requires a Material Safety Data Sheet (MSDS).
 - a. This covers every chemical, or substance under the sun. For example, this ordinance allows the city to regulate the storage of plastic. While plastic is combustible, no other regulatory agency considers it as hazardous material, or hazardous substance.
- 2. The persons operating warehouses have no idea what is being regulated as the ordinance's definition of hazardous materials. Chemicals they may not even know, have MSDS sheets, as the manufacturer of the material may not have sent an MSDS with each shipment. OSHA only requires that MSDS sheets be made available on demand. If a warehouse receives something that has an MSDS, but if that MSDS is not sent out with the product, the warehouse would be in violation of the ordinance and not even know it. This is true on all products not covered by U.S. D.O.T. regulations.
- 3. The real problem here is that there is no list, or reference to already existing list of chemicals and materials that are to be regulated by the City of Laredo. These lists are available.

By not having a real defined list of chemicals, and quantities of those chemicals, that are to be regulated, enforcement becomes a judgement call of the fire department. This requires the fire department to determine on their own what is hazardous and what is not. I do not believe the city would want to have the liability of saying whether or not a chemical is hazardous.

There are other areas of concern, like facility definitions, and permitting processes that I will not go into here because of length of the issues.

I think you can see the problems we have. I know the ordinance deals with very technical issues, and for that reason I am asking you to have this ordinance reviewed. It is imperative that we have an ordinance that is enforceable, and makes sense to the regulated community. The citizens of Laredo deserve to have an ordinance which will provide a safe and environmentally sound community."

The problem is due to the elevation of the railroad tracks which causes the water to concentrate in the area. Two properties in the low line area were affected. Mr. Rivera said that the solution will be to make a design that would direct the water away from the properties. He also added that one homeowner asked if Tex-Mex would allow the construction of some sort of retention wall. After consulting with Mr. Dominguez, Tex-Mex would allow the construction of that wall, but it shall not be constructed 1 or 2 feet inside Tex-Mex property within their right-of-way. Mr. Rivera mentioned that the cost of such wall would be between \$8,000 to \$10,000, depending on the design.

Cm. Bruni would like to re-engineer the area since there are two things contributing to this problem: the elevated railroad tracks and the public water that is heading towards that right-of-way. He asked that staff conduct a drainage study and if the project falls within the \$10,000 cost estimate, that we approach Tex-Mex and ask them for a 50% contribution.
