V. COMMUNICATIONS AND RECOGNITIONS

a. Announcements

- 1. City Manager, Florencio Pena, introduced Rosario Cabello as the new Finance Director.
- 2. Cm. Agredano introduced Jose Perez, former Cm. from District I.
 - Mr. Perez commented that in the last 10 years the City has spent over \$45 million dollars in projects, which consists of street paving, new water and sewer lines, the construction of two water towers in Los Presidentes and Sierra Vista areas. In addition, the construction of a 24 inch water line from the line tanks connected to the new water and sewer lines; the light enhancement programs. Also constructed was this recreational park, Cigarroa Recreational Center, established the COPS program, purchased an ambulance for the South Laredo Fire station, and the newly opened Fire station located at the Hwy. 359 area.
- 3. Rene De La Viña, a concerned Teacher and Citizen, stated that several teachers have noticed that when US Senator Phil Graham; US Senator Kay Bailey Hutchinson; and US Representative Henry Bonilla come to Laredo, it is always a 'business related' type issue. They would like to be advised whenever Federal Representatives will be coming to town because they have some educational issues that they would like to address to them. On another issue is the \$50 limit tax base in which he is not in agreement. On a 3rd issue he recommends a heated indoor swimming pool for therapeutic purposes.
- 4. Jeffrey Coffey, from Houston, Texas, stated that today they had the pleasure of turning in their qualification statement at the Council's request to look at secondary source of water.
- 5. Ms. Sonia Jodry requested that the Mayor proclaim this Wednesday as Cigarroa High School Toros Day.
- 6. Mayor Flores made a statement concerning the executive session held on November 15, 1999:

"The Council met in Executive Session and discussed first in private and later with the City Manager what it felt were several issues concerning the performance of the City Manager; while I cannot give you the specifics because it is a subject for continuing executive session deliberation and more importantly, the very nature of the matter requires our careful, and respectful consideration. I can provide you with a few comments.

We realize that there is public interest in this subject and rightfully so. There are probably few if any, more important people decisions that this Council can make than the decision it makes concerning its City Manager. So where are we regarding the Council's working relationship with the City Manager, where we are with our current City Manager, is really about where we are and where we want to be with our City; and that is a real motivator, the nut shell if you will.

Laredo is at a crossroads as are many other cities perhaps, but not more than Laredo. Laredo is on the threshold of taking great strides. The

Council and I see Laredo on the verge of great days locally, statewide, and nationally. We have always seen and been at our country's southern border. We have been momentous and historic many times before. We have had other opportunities to grow and to prosper, but I am here to tell you that never before had the opportunity been there as we have it before us today. We have no time to lose. We have many serious challenges before us. We have no time to be reluctant even tentative about developing a strategy for success. Everything that this Council and city staff do in the next year and the next 10 years must be focused on communicating a total commitment and a resolve to lead. We already see progress in many areas, but that is not enough. We cannot afford to have any semblance of obstructionist leadership. We can and should lead in the development of not just Laredo but of all border cities, of our state and nation, as well as our international partners in as many positive ways and directions as we can. And we must start with our own house. And that is where we are today.

The Council and I want to be careful, but we need to be bold. W have had good leadership in the past few years, but we must ask ourselves, as your elected representatives, can we do better? And that is where we are today. The leadership that the City needs must start at the top. Obviously we have concerns whether Mr. Pena is the person to take the City into the next millennium. The unanimous vote last Monday said that. Perhaps a 45 day period is not what we needed, perhaps the Council itself should be more prompt in moving ahead, but we want to be careful, we want to be thorough, fair and we will be. We do know, that we must be bold and waste no time in forming the best possible City leadership for tomorrow."

Mayor Flores read a letter into the record from Chevron, letter quotes:

"Please be advised that Chevron U.S.A. Inc. opposes the annexation of 2,447.7141 acres, more or less, known as Tract 7, located between the city limit line and the north border of the City of Rio Bravo.

Chevron U.S.A. Inc. owns several oil and gas leases covering lands within said Tract 7. Under the terms of these leases, Chevron has drilled or has caused to be drilled numerous wells which have been producing in paying quantities for over twenty years.

Chevron's first objection to this proposed annexation involves the issue of safety. There is always an element of risk involved when residential development encroaches upon an area containing producing wells. Chevron's first priority is to always conduct its operations in a manner that puts the safety of people and the environment first. However, this annexation by the City of Laredo increases the potential of an undesirable event because of the proximity of new residential development to existing production facilities.

In addition to the above objection, the proposed annexation of said 2,447.7141 acres into a R-I Zone (Single Family Residential District) will severely restrict Chevron's ability to conduct reworking and recompletion operations on existing wells and to conduct new drilling operations on said lands.

The prior rights of the working interest owners and mineral owners to produce and develop the minerals under said lands should be protected from restriction necessitated from subsequent residential development.

If the City of Laredo nevertheless decides to annex this land over Chevron's objections, please bear in mind that we will need a buffer zone around our existing facilities in which to perform future reworking and recompletion operations. We therefore ask that no residential building or structure be permitted within 400 feet of our existing facilities (or within 600 feet for schools, hospitals, churches or public buildings). Since Chevron would be prohibited from placing our facilities within 400-600 feet from existing buildings, we believe it only fair that the City refuse to permit new buildings from being built within 400-600 feet from our existing facilities.

In addition to the buffer zone around existing facilities, we will of course need to be assured of continued access to our facilities and the continued ability to transport production to market.

The City's Planning and Zoning Commission decided to recommend this annexation despite the objections received from Chevron and other interested parties. Chevron prays that the City of Laredo will give full consideration to Chevron's objections to this annexation, and give strong consideration to Chevron's request regarding the limit on new building permits.
