V. COMMUNICATIONS AND RECOGNITIONS Announcements

a.) Cm. Agredano announced that he received a letter addressed to him, Council members, and the Mayor from Cigarroa High School. The letter with signatures quotes as follows: "Being that Cigarroa High School has made history in Laredo by winning the first Area Championship football game, we feel that it is imperative to have pride for South Laredo. For example, we've noticed that subregions in Laredo have something symbolic that represents their school. We have noticed that there is a water tank within the vicinity of our campus. Through a beautification effort, we the students can help our environment by cleaning the area as well as restoring and repainting the tank with our school mascot."

Cm. Agredano added that he spoke with Mr. Roman and Mr. John Vidaurri about working on painting their school mascot in the water tank.

b.) Luis Dovalina had an announcement directed to Council about meetings they had on November 29, December 2, and December 3, 1999, concerning the election of the 'contract'. Currently there are 261 dues paying members, 59% of the members voted and 99.98% stated 'no' to a one (1) year deal. He is requesting to send back to Council and see if they can get a multi-year contract.

Mayor Flores stated that it is an item of communication and they will put it on the next agenda, if they need to formalize it, but that the City Attorney will get together with Mr. Luis Dovalina to set up a schedule.

c.) Cm. Alvarado read a letter from a constituent hearing on the Mines Road in reference to La Bota entrance as follows:"Due to the construction of Mines Road we have had numerous accidents recently in front of La Bota entrance, the latest being last night.

The problem is entering La Bota from the northbound lane crossing in front of the southbound traffic. The traffic going southbound is bumper to bumper; there will be some considerate drivers stopping to allow cars to cross to enter La Bota, while both drivers are stopped in the second lane row. We have inconsiderate drivers using the shoulder as a third lane recklessly and speeding with no thought of any one but themselves. We are requesting that until the lights are installed to have either a road barrier or a shoulder near by La Bota entrance so that the truck drivers can use it as a third lane or have a traffic officer manage this intersection.

We would also like to remind you that we have a new school and that school opened today, which will increase the traffic at this intersection."

Risk Management Plan Regulatory Background

- 1990 U.S. Congress approved Clean Air Acts Amendments requiring EPA's development of Accidental Release Prevention Program
- 1996 EPA issued ARPP Risk Management Plan regulations

Risk Management Plan Regulatory Overview

- Effective for 130 toxic or flammable chemicals
- Required Risk Management Plans be submitted by June 21, 1999
- Established intent to make Risk Management Plans available to the public

Risk Management Plan Effects to City of Laredo

- Risk Management Plans required for chlorine and ammonia
- City of Laredo uses these chemicals:

Chlorine Disinfection of Potable Water
Chlorine Disinfection of Wastewater
Ammonia Disinfection of Potable Water

Risk Management Plan Five Steps to Preparing Plans

Step One: Assign responsible charge for use of the chemical through a Management System.

Step Two: Hazard assessment to define chemical offsite consequences from an accidental chemical release:

- Worst Case
- More Likely Case

Step Three: Prevention program to establish an EPA standard approach for chemical accident prevention.

Step Four: Emergency response plan for addressing notification and

coordination with emergency responders in the event of an

accident.

Step Five: Submission of Risk Management Plan through electronic means.

Risk Management Plan - Laredo Plan of Action

- Laredo Water and Wastewater Facilities evaluated by Montgomery Watson
- Twelve facilities with chlorine
- Four facilities with ammonia

Risk Management Plan - Emergency Response

- Emergency response to a chemical release requires Hazard Material Technician level training. Laredo's Fire Department has this type of training at several fire stations.
- The Laredo Fire Department was able to demonstrate the capability to respond to an accidental release of a chemical between 3 and 15 minutes.

Risk Management Plans - Actions by the City

- The City needs to complete design of some chemical neutralization in several locations.
- The City needs to continue to support training of both Utility and Fire Department personnel in Emergency Response.
- The City has already taken actions to reduce some volumes of chlorine in order to reduce risk.

- 7. A. Request by Council member John C. Galo
 - 1. Staff update on city wide First Time Homebuyer Down payment Assistance Program, with possible action.

2. Status report of vacant properties owned by the City of Laredo.

Erasmo Villarreal, CD Director, reported that they have identified 40 individual lots that are buildable. They also did a study that identified the City of Laredo as the trustee for some of the properties; out of that list they have identified 7 additional lots that are buildable. They also contacted L.I.S.D. and they have available 3 lots that could be utilized as buildable properties.

Cm. Galo requested a written list of the City properties.

Mr. Villarreal stated that he would submit a written report of all the properties available along with a map identifying their exact location.

- B. Request by Council member Eliseo Valdez Jr.
 - Status report on paving of Ryan Street between Springfield Avenue and Marcella Avenue.

Rogelio Rivera, City Engineer, reported that they do have it assigned to a project. They have a design of the street, however, it is among the other list of the streets that remain unfunded. At one time it was going to be used for development as part of a half block the city owns.

Cm. Valdez asked on the portion of Ryan Street from East San Francisco to Monterrey.

Mr. Rivera stated that they are still on a project assigned and a list was submitted of a breaking of the projects of the blocks that remain unpaved into three categories. They are recommending for that area to be closed and use it for a development together with a park.

Cm. Valdez requested for it to be closed and be part of the development of that park.

2. Request with possible action on the Express Bus from El Metro Center to Mall Del Norte.

Peter Behrman, Metro Manager, reported that express service is considered a premium service so that way they can get a little bit more of revenue. They are placing a Christmas Shopper; that bus will start about a week and a half before Christmas and run every day up to Christmas with two buses on the weekend. By the next Council meeting he should get some total amounts on the money they will be losing since the Shopper will only be .25.

3. Request for status report on street light West of Alma Pierce Elementary.

Cm. Valdez asked to be tabled because it was already taken care of.

Request for information on City's Appeals and Grievance
 Committee on how many cases have been before the committee
 these past 2 years – what was resolved, what action was taken

and what action does the city take on allegations made by exiting employees. Also, requesting information on makeup of committee (what governs or dictates the makeup of committee) with possible action on changing the makeup of committee if it needs to be balanced out.

Cm. Valdez stated that the reason he put it on the agenda was because council members receive calls from employees that are on the urge of getting fired or are suppose to go before the committee or have been before the committee, and they give all kinds of different stories. He was concerned because some of those stories are disturbing at times. Some employees start making allegations and whether they are true or not, he feels they should be looked into especially when it pertains to personnel matters, purchasing procedures, or auditing concerns.

Cm. Valdez requested that the City's Appeals and Grievance Committee be reviewed by Council and he wants the employees to feel that their hearings are going to be objective, that they are not going to intimidated, and that they are going to get a fair chance of being reinstated or if they need to be reconsidered for reemployment, if they haven't already been fired. He is concerned if the committee has anybody with the experience in labor laws.

Dan Migura, Administrative Services, reported that there is a rotation every 2 years and at that time they have an election. There was an election recently in which the employees elected two city employees to represent them, the City Manager also is responsible to appoint two new individuals, and the Mayor can choose to appoint another citizen.

Election held in November with Thelma Acosta (City Manager's Office) and Ricardo Martinez (Health Department) as the chosen employees, they are also pending two appointees of the City Manager, and the acknowledgement from the Mayor whether to continue or not with current appointment for our citizen or if there will be a change.

Cm. Valdez asked who gets to sit in on these hearings other than the committee members.

Mr. Migura stated that by ordinance there is a representative from the City Attorney's office as well as himself, to answer any questions that have to do with legal or with human resources.

He stated that it is not a public meeting but that it is open to the public.

- D. Request by Council member Mario G. Alvarado
 - 1. Presentation by Ricardo Lucio regarding the clean up of brush areas along the river with possible action.

Cm. Alvarado stated that the concern is the drug trafficking movement and illegal crossing of people along the border.

Mayor Flores stated that they would need to bring back a presentation to Council because of the need to identify the property that is privately owned and the property that may be City owned, and get some recommendation on how to proceed.

Larry Dovalina, Assistant City Manager, stated that they are starting to identify all the properties along the river and at some point they are going to put together an entire program that deals with the entire riverfront.

Cm. Alvarado requested a status report for the next meeting.

2. Update from the Laredo Police Department on traffic enforcement efforts on the Mines Road area with possible action.

Fructoso San Miguel, Assistant Police Chief, reported that they will increase the patrols on Mines Road. As of last week, they had six (6) motorcycle officers on Mines Road, but circumstances occurred on the Unitec area that they had to send a couple of officers to that area. Their plan is to have four (4) traffic motorcycle officers as a permanent solution and one (1) patrol officer from this district on Mines Road.

Luis Landin, Traffic Director, reported that he met with DPS Sgt. Mario Salinas, Lt. Torres from the Police Department, and the construction foreman of H.B. Zachry, to develop a task force, which has been organized already and will meet every Friday to discuss the problems that exist during that specific week on Mines Road.

Mrs. Cookie Muller and Greg Jones from La Bota Subdivision spoke on this subject.

Pepe Treviño, Chairman of the Transportation and Traffic Safety Committee, commented on this issue.

3. Presentation from Texas Department of Transportation staff on the ongoing construction work on FM1472 with possible action.

Mr. Carlos Rodriguez from TxDot, reported that there are several projects that are occurring in the vicinity of 1472, one is the approach roadway to International Bridge IV, neighboring that will be the one on

Milo Interchange that is also a relief to the 1472. The other one would be between the approach roadway and Columbia Bridge. The contractor is still on schedule for the proposed completion date of March 15.

Cm. Moreno requested a study report from the City Manager on the River Road.

4. Discussion with possible action, on a joint resolution, with the Nuevo Laredo City Council to promote a public awareness campaign and the enforcement of each country's respective laws that will address underage drinking and the safety concerns of all citizens along the border.

Cm. Alvarado requested to conduct a joint effort with Nuevo Laredo, Tamaulipas. This effort will focus on a public awareness campaign to address the problem of drug usage, under-age drinking, and drunk driving along the border area. Secondly, to increase efforts to enforce the laws pertinent to each country, understanding that there are differences in the legal age for consuming alcoholic beverages and thirdly developing a special program that will address this issue. These special efforts will be conducted by each individual city in accordance with the respective laws of each country.
